## TERMS & CONDITIONS

In these general conditions, DNA Media Services Ltd. shall be referred to as the company and persons or bodies to whom the company is selling or supplying goods or services are referred to as the client. Products, services or goods supplied or sold by the company are referred to as goods. No variance shall be made in these conditions except by agreement in writing by the company representative.

### Prices

All prices quoted are subject to VAT at the prevailing UK rate unless otherwise stated as inclusive. The price payable shall be the company ruling price at the date of sale provision or despatch with any appropriate shipping or postal charges specified. Pricing errors or omissions shall be rectified by the company as soon as they are discovered, and any such errors or omissions will not be binding upon the company, nor permit the client to vary the contract or any of its terms.

### Quotations and Estimates

Unless a contrary intention is provided in writing, quotations and estimates are open for a period of 28 days from the date thereof. Clerical errors or omissions shall be rectified by the company as soon as they are discovered, and any such errors or omissions will not be binding upon the company, nor permit the client to vary the contract or any of its terms.

### Payment

For non-account clients, payment will be made with order or on presentation of invoice. For account customers, payment will be due from the date of invoice and in any event not later than 30 days from the date thereof. If payment is not made in full by the due date, the company shall be entitled to recover, from the client, in addition to the price of the goods, interest at the rate of 2% above National Westminster Bank Plc unsecured lending rate until such date as the payment is made.

### Title

The ownership of goods shall remain with the company, which reserves the right to dispose of all such goods until payment in full for those goods has been received. If payment is overdue, in whole or in part, the company may (without prejudice to any of its other rights) recover or resell the goods (or any part thereof) and may enter the clients premises by its servants for that purpose.

### Availability

All goods and services are sold or supplied subject to availability.

### Non-Delivery

The company shall not be liable in whole and/or in part for any direct or indirect loss or any part thereof, in consequence of any late or non delivery or partial late or non delivery of goods. The client shall have no right to cancel an order or refuse to accept goods on the grounds of delay resulting from circumstances beyond the company's control. Cancellations cannot be accepted for goods ordered at the clients request.

### English Law

These conditions and any contract made in accordance herewith shall construe and take effect in accordance with English Law and any such contract shall be deemed to have been made in Woking, England. If any provisions of this agreement should be held to be invalid, it shall to that extent be severed and the remaining provisions shall continue to have full force and effect.
